this deadline will be rejected.

Bids shall be opened in presence of Bidders' representatives who choose to attend on 14:00 Hrs, on 2078-4-03 (18th July 2021) at the office of Kalika Municipality, Office of Municipal Executive, Redcrossgram, Chitwan. Bids must be valid for a period of 90 days from the day of bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of following amount, which shall be valid for minimum 30 days beyond the bid validity period.

7. If the last date of submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized

with effect from the original bid submission deadline.
