Invitation for Electronic Bids for procurement of
"Supply and Delivery Fabricated Steel Parts for Badhare Trail Bridges"

1. The Government of Nepal (GoN) has allocated TB-SWAp funds to Kalika Municipality for Trail Bridge Program and the Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Bid is open to all eligible Nepalese Bidders.
2. The Kalika Municipality invites electronic bids from registered fabricators for supply of fabricated steel parts for following Trail Bridges under National Competitive bidding procedures specified in Public Procurement Act and Regulations. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.
4. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Kalika Municipality or may visit PPMO egp system www.bolpatra.gov.np/egp.
5. Bidding documents is available online and can be downloaded from e-GP system: www.bolpatra.gov.np/egp. Interested bidders shall register in the e-GP system and deposit the cost of bidding document in the following bank.

6. Interested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egp, on or before 12:00 Hrs on 2078-11-25 (9th March, 2022). Documents received after this deadline shall not be accepted.
7. Bids will be opened in the presence of Bidders' representatives who choose to attend at Kalika Municipality on 14:00 HRs. on 2078-11-25 (9th March, 2022) at the office Kalika Municipality. Bids must be valid for a period of 90 days after bid opening and must be accompanied by bid security, amounting to a minimum of NRS. 19,000/- which shall be valid for 30 days beyond the bid validity period.
8. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Above mentioned Account and submit bank deposit voucher along with the bid.
9. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
10. Pre-Bid Meeting shall be held at the office of Kalika Municipality on 2078-11-08 (20th Febraury, 2022) at 14:00 Hrs.
