1. Kalika Municipality, Chitwan invites electronic bids from Nepalese eligible bidders for the Construction of following projects under National Competitive Bidding procedures. The estimated amount for the works is **NRs. As listed below** (*Excluding VAT and PS*).

4. Pre-bid meeting shall be held at **2080-07-14 (October 31, 2023)** at **14:00 Hrs** at Kalika Municipality, Office of Municipal Executive, RedcrossGram, Kalika, Chitwan, Nepal.
5. Electronic bids must be submitted to the Kalika Municipality Office of Municipal Executive, Chitwan through PPMO website www.bolpatra.gov.np/egp or before **12.00 noon** till **2080-07-23 (November 09, 2023)** Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13.00 Hrs** on **2080-07-23 (November 09, 2023)** at the Kalika Municipality, Office of Municipal Executive, Chitwan. Bids must be valid for a period of **90 days** i.e., 2080-10-24 (February 07, 2024) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. As listed below** which shall be valid for **30 days** i.e., 2080-11-25 (March 08, 2024) beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
